



**STATEMENT OF POINTS ON APPEAL**

1. The exclusion of same-sex couples from eligibility for death benefits, *see* AS 23.30.215, 23.30.395, 25.05.011, 25.05.013, & Alaska Const., art 1, § 25, violates Sections 1, 3, 7, and 22 of Article I of the Alaska Constitution, which, among other things, guarantee the right to equal protection, the right to liberty, the right to due process, the right to be free from sex discrimination, and the right of privacy, as well as the Equal Protection and Due Process Clauses of the Fourteenth Amendment of the U.S. Constitution.




