- 1. My name is Kelly Noe and I am a plaintiff in the above action. I have read the complaint filed in this action and I can verify that all of the facts are true. I submit this declaration in support of our request for a preliminary injunction.
- 2. I am 31-years-old. I live in Kenton County, Kentucky, with my wife, Kelly McCracken.
- 3. Kelly McCracken and I have been in a committed relationship since 2009.
- 4. We both wanted children. From the beginning of our relationship, we discussed adding children to our family.
- 5. We married in Massachusetts in 2011.
- 6. In September, 2013, I became pregnant with our first child. We expect to welcome our son or daughter in June, 2014. We plan to hyphenate our last names for our child's last name. Our child was conceived through artificial insemination with sperm from an anonymous donor.
- 7. Kelly McCracken has been equally involved in the fertility process and pregnancy. She will be at our child's birth and if all goes as planned, she will cut the umbilical cord. She will be this child's parent in every sense.

- 8. After the birth of our child, we will apply for an Ohio birth certificate through the Cincinnati Health department, Office of Vital Records. Only my name, however, will be on the birth certificate.
- 9. It denigrates my family to refuse to put Kelly McCracken's name on her child's birth certificate.
- 10. Ms. McCracken and I live as a married couple. We plan to provide a secure and happy home for our child and look forward to our child's arrival. Ohio's denial of the true nature of our family demeans and harms all of us.


