With Dkt. No. 269, Intervenor-Defendant-Appellee Coalition for the Protection of Marriage (“Coalition”) moved for recall of the mandate (Dkt. No. 267) and a stay of the Ninth Circuit’s October 7, 2014 Opinion (Dkt. No. 265) invalidating and enjoining enforcement of all of Nevada’s statutory and constitutional provisions preserving marriage as the union of a man and a woman. In support of its motion, the Coalition joined in and adopted Governor C.L. (Butch) Otter’s Emergency Motion Under Circuit Rule 27-3 for Recall of Mandate and Stay filed in *Latta v.
