I AM AN EX-GANG MEMBER WHO IS ALSO OPENLY HOMOSEXUAL. SINCE BEING IN PRISON IVE HAD SEVERAL OPI'S FILED ON MY BEHALF BY OFFICERS BECAUSE OF THE PROBLEMS IM HAVING. IVE BEEN ASSAULTED & THREATENED IN THE PAST. ALL OF THESE THINGS HAVE BEEN DOCUMENTED. THE UNITS ADMINISTRATION'S HAVE REFUSED TO TAKE ACTION TO ENSURE MY SAFETY. IN 2007 I WAS ASSAULTED IN ALLRED UNIT IN WHICH DIS HAD TO BECOME INVOLVED. THE REASON WHY I WAS ASSAULTED WAS BECAUSE I AM A HOMOSEXUAL & PASSIVE. YET, I WAS REFUSED SAFE KEEPING. ON 11-4-13 I WAS TAKEN IN FRONT OF VCC HEARD BY MAJOR MAREZ FOR POSSIBLE HOUSING AND SAFE KEEPING. HE SAID THAT I "CLAIM TO BE HOMOSEXUAL" WHICH IS A STEREOTYPICAL & DISCRIMINATORY REMARK STATED AS IF THERE IS A CERTAIN WAY A HOMOSEXUAL IS SUPPOSED TO ACT OR LOOK TO BE DEEMED HOMOSEXUAL. YET, I AM GAY AND HAVE BEEN TAKEN ADVANTAGE OF IN THE PAST. ON RECORD IVE HAD 12 OPI'S FILED ON MY BEHALF SINCE JULY 2011 & ALL HAVE HAD TO DO WITH (1) MY PRIOR GANG AFFILIATION & (2) HOMOSEXUAL ACTIVITY. MY DOCUMENTED ALIAS IS "PASSION" WHICH IS NOT MASCULINE AT ALL. ALL OF MY PROBLEMS STEM FROM BEING A HOMOSEXUAL IN A GENERAL POPULATION OF OFFENDERS WHO HAVE CONSTANTLY ATTEMPTED TO TAKE ADVANTAGE OF ME OR REQUEST SEXUAL FAVORS.... JONES V. I AM A HOMOSEXUAL OFFENDER AND EX-GANG MEMBER. IVE HAD SEVERAL ALTERCATIONS WITH OTHER OFFENDERS BECAUSE I AM GAY. IVE BEEN PROSECUTED AS WELL AS THREATENED BY SEVERAL OFFENDERS AS WELL. IT IS THE RESPONSIBILITY TO ENSURE THE SAFETY OF ITS OFFENDERS FROM THREAT, PHYSICAL HARM OR SEXUAL ASSAULT. IN THE PAST (2007) I WAS SEXUALLY ASSAULTED. IT WAS REPORTED AND I CHOSE TO FILE SUIT. MY FAMILY REQUESTED I BE PLACED IN SAFE KEEPING TO ENSURE THIS HAPPENED NO MORE. I WAS TRANSFERRED TO ANOTHER UNIT. I WROTE A LETTER TO WARDEN FOX REQUESTING HOUSING ON SAFE KEEPING FOR MY SAFETY. I RECEIVED NO RESPONSE. DURING MY CONFINEMENT IN TDCJ IVE HAD SEVERAL ONGOING AND WELL DOCUMENTED LIFE THREATENING ISSUES ALL ROOTED IN THE FACT THAT I AM AN AT RISK OFFENDER, TRANSFENDER WITH AN ALIAS OF "PASSION" AND HOUSED IN THE GANG INFLUENCED GENERAL POPULATION. I WAS SEXUALLY ASSAULTED ON 3-29-07 AND ASSAULTED WITH A WEAPON ON 11-20-13 BY A KNOWN GANG MEMBER. SINCE JULY OF 2014 THERE HAVE BEEN AT LEAST 18 OPI'S FILED ON MY BEHALF. ON 8-1-14 I WAS TAKEN TO UCC FOR AN OPI AND SIMPLY RECOMMENDED UNIT TRANSFER. YET, TRANSFERRING ME FROM UNIT TO UNIT IN GENERAL POPULATION DOES NOTHING TO RECTIFY THIS PROBLEM THAT IS PERVASIVE. TDCJ DOES NOT MONITOR OR CONTROL ITS GANG INFLUENCED GENERAL POPULATION ENOUGH TO PROTECT ME FROM VIOLENCE AT THE HANDS OF OTHERS. AFTER BEING SEXUALLY ASSAULTED IN 3-29-07 SIMILAR PROBLEMS PLAGUED ME. AFTER THE 11-20-13 ASSAULT WITH A WEAPON SIMILAR PROBLEMS PLAGUED ME. I HAVE BEEN THREATENED WITH MY LIFE AS WELL AS THREATENED WITH RAPE. HOUSING ME IN GENERAL POPULATION TO REPEAT THE SAME CYCLES WITH DIFFERENT OFFENDERS IS ABSURD. ESPECIALLY WHEN ITS BEEN SHOWN THAT I AM AN OFFENDER WITH A HIGH POTENTIAL FOR VICTIMIZATION. I AM WRITING YOU TO REQUEST YOUR ASSISTANCE IN A VERY SERIOUS MATTER.

MY NAME IS JOSHUA D. ZOLLICOFFER #1138161. I AM TRANSGENDER AND MY KNOWN ALIAS IS PASSION. I AM WRITING BECAUSE I AM CURRENTLY ON TRANSIT STATUS ON THE ROBERTSON UNIT AWAITING REPLY FROM STATE CLASSIFICATION FOR A RECOMMENDATION OF UNIT TRANSFER ON 8-1-14 BY ASSISTANT WARDEN WEBB.

DURING MY INCARCERATION I HAVE CONSTANTLY BEEN PREYED ON BY OTHER OFFENDERS AND HAVE COME TO SERIOUS HARM BECAUSE NO UNITS ADMINISTRATION HAS TAKEN THE STEPS TO PROTECT ME. ON 3-29-07 I WAS SEXUALLY ASSAULTED ON THE ALLRED UNIT. I WAS DENIED HOUSING ON SAFE KEEPING AND SIMPLY TRANSFERRED TO ANOTHER UNITS GENERAL POPULATION TO FACE THREATS AND ABUSE. I HAVE HAD TO BE SEXUALLY ACTIVE IN ORDER TO REMAIN RELATIVELY SAFE IN GENERAL POPULATION. THAT SHOULD NOT HAVE TO BE THE CASE THOUGH.

ON 11-20-13 I WAS ATTACKED WITH A WEAPON BY A KNOWN BANGER MEMBER. I WAS CUT ACROSS THE FACE AND FOREHEAD 8 TIMES WHILE BEING CALLED A SWITCHING FARTHOLE. MY INJURIES REQUIRED 36 STITCHES. THIS HAPPENED AFTER I INFORMED THE HUGHES UNIT ADMINISTRATION THAT THIS SAME OFFENDER WAS TRYING TO FORCE ME TO BE WITH HIM. THE HUGHES UNIT ADMINISTRATION DISREGARDED THE THREAT, HOUSED ME ON THE EXACT SAME POD AS HIM. AGAIN I REQUESTED HOUSING ON SAFE KEEPING. I WAS DENIED AND SIMPLY RECOMMENDED UNIT TRANSFER. I WOUND UP ON THE ROBERTSON UNIT AND NOW FACE THE THREAT OF SERIOUS HARM BY OFFENDERS WHO WERE CLOSE TO MY ATTACKER WHEN HE WAS HOUSED ON THE ROBERTSON UNIT. 6 MONTHS PRIOR TO THE 11-20-13 ATTACK ON ME.

I HAVE BEEN THREATENED WITH MY LIFE, THREATENED WITH RAPE AND FEAR FOR MY WELL BEING. IVE INFORMED THE UNITS ADMINISTRATION. WROTE SEVERAL GRIEVANCES, WROTE THE PREA OMBUDSMAN AND SPOKEN TO OIG TWICE. ON 4-7-14 I WAS RECOMMENDED UNIT TRANSFER. ON 6-5-14 THE SAFE PRISONS OFFICE FORWARDED A RECOMMENDATION TO HOUSE ME ON SAFE KEEPING. BOTH WERE DENIED BY STATE CLASSIFICATION. MY LIFE IS IN DANGER AND I NEED HELP. I HAVE BEEN THE VICTIM OF 2 VERY SERIOUS CRIMES AND CONTINUE TO FEAR FOR MY WELL BEING.

SIMPLY TRANSFERRING ME FROM UNIT TO UNIT IN GENERAL POPULATION DOES NOTHING TO RECTIFY THE PROBLEMS THAT I AM HAVING. I REQUEST HOUSING ON SAFE KEEPING TO PREVENT FURTHER RAPE, EXTORTION AND ATTEMPTS ON MY LIFE. I REQUEST YOUR ASSISTANCE. THANK YOU.
